5. In order to eliminate confusion the day of the wedding, the studio shall have the right to insist being the exclusive photographer. This includes all professional or non-professional still, movie or video photographers. At no time will posed individual or family group portraits be allowed to be videotaped. The photographer shall at his or her discretion insist upon where removal of any and all persons with cameras, flash or floodlights from all areas where he or she may be operating. The studio shall assume no responsibility for any photographs ruined by outside interference from these persons.

6. Should the photographer be required to remain on location and continue photographic services beyond the contract time for reasons not under his/her control, an overtime fee of \$125 for each hour/per photographer will be assessed. These overtime fees will be due before any work is released.

7. A travel fee will be assessed on an individual basis for locations outside a 20 mile radius along with tolls, lodging and parking fees.

8. For the coverage over four (4) hours, dinner will be provided for the photographer and assistant(s). To ensure the studio captures all events, seating should be provided in the same room as the bridal party.

9. The studio takes utmost care with respect to the exposure, development and delivery of the photographs. However, in the event the studio fails to comply with the terms of this contract, or complicity becomes impossible due to natural disaster, fire, flood, theft or equipment failure, the studios liability is limited to deposits paid.

10. The studio shall not be liable for any damages arising from personal injury or property damage sustained by any person(s) in or about the area of the wedding reception or other photographing area, from any acts of the studio or its agent.

11. The failure of the photographer to take any or produce any specific photograph shall not be a defense to an action brought on the photographer for monies due under this contract as long as sufficient photographs have been taken to cover the amount of the photographs order pursuant to this contract.

12. State sales tax will be added to all purchases in accordance with California state law.

13. All collection costs, bank charges, fair attorney fees, maximum allowable interest rate on past due accounts and court costs will be paid by the commissioning person first or persons receiving services items.

14. All commitments on the part of the studio must appear on the face of this contract.

15. In order for us to properly photograph your wedding, we suggest you have a consultation with your photographer one to two weeks prior to your wedding.

1. Payment schedule \$1000 on acceptance of contract, 50% of the remainder 60 days before and Balance 30 days before wedding. 50% payment of any order for additional prints due when order is placed.
2. Upon acceptance of this agreement, the studio will reserve the time and date as specified. Since reserving this date will result in loss of revenue through declining other assignments, the customer understands and agrees that the deposits or payments paid to the studio are not refundable. However, in the event that the contract is cancelled or postponed, a \$750 cancellation charge will be deducted from your deposit if: (1) Written notice is received 60 days before the event, and (2) another engagement of equal or greater magnitude is retained for that day, otherwise no deposit or payments, or parts thereof, will be refunded.
