Research synopsis: My primary research focuses on social inequalities linked to maternal health and child welfare policies. My current book project traces the development of child welfare policies regulating maternal behavior during pregnancy in the United States. In related lines of research, I study racial inequity in medical reporting of substance-exposed infants, the rise in US maternal morbidity rates, and risk discourses in maternal health and child welfare. I have published on the politics of educational policy advocacy, communal and organizational change, and mixed methods research, and I have a forthcoming book chapter on the origins of poverty governance in American child welfare.
